He is a retired Judge Advocate from the United States Army where he served for 20 years and attained the rank of Lieutenant Colonel. After his military service, he joined the litigation department at a major law firm where he headed the firm's Military & National Security Law practice group. He participated in numerous military operations around the globe, including in the Balkans, Southwest Asia, and Southeast Asia. He frequently speaks and writes on military law topics and has co-authored multiple military justice books. He was also a part of the historic "Yale Draft" (Principles) on Military Justice, an improvement of the existing United Nations document on the same subject, at a Yale Law School conference attended by global jurists and representatives of the United Nations. Franklin also serves as a Court of Appeals judge with the Mississippi Army National Guard. He is also associated with the International Society of Military Law and the Law of War, Brussels. Belgium.

## Professor Shruti Bedi

Currently Professor of Law and Director of the University Institute of Legal Studies, Panjab University, Chandigarh, India. An internationally recognized legal scholar, she is the first International Fellow at the National Institute of Military Justice, Washington DC, USA with Navdeep Singh, and a Visiting Professor at Universitas Airlangga, Indonesia. She also serves as the Director of the Centre for Constitution and Public Policy. With ten books and over 90 publications to her credit, her work also explores constitutional law, counterterrorism, and AI law. A TEDx speaker and recipient of The Phenomenal She, 2022 award by the Indian National Bar Association, she has been honoured by the British High Commission for her contributions to India-UK legal heritage.

## Navdeep Singh

Former Major and practicing lawyer at the Punjab & Haryana High Court, India on the constitutional side, he is a globally recognised expert and practitioner of constitutional law, military-related law and reform in administration of justice, including military justice. He was also the founder President of the Armed Forces Tribunal Bar Association, Chandigarh, India. Along with Franklin Rosenblatt, he too was a Member-Participant of the "Yale Draft" at the Yale Law School. He is a former Member of a high-level Committee of Experts constituted by the Indian Ministry of Defence on directions of the Prime Minister to reduce litigation and initiate reform in redressal of grievances in the Armed Forces. He is Member of *International Society for Military Law and the Law of War* at Brussels, Belgium, the first International Fellow of the National Institute of Military Justice at Washington DC, USA and one of the five appointed members of the military justice advisory committee of the Commonwealth Secretariat at London.
